SUBJECT: Oklahoma Parents as Teachers (OPAT) Parent Training Program Grants

On June 26, 2014, the State Board of Education approved \$1,000,000 in funds for the Oklahoma Parents as Teachers (OPAT) program to be expended for competitive grants to public school districts. Per correspondence from Mr. Preston L. Doerflinger dated June 27, 2014, the 0.12% cut leaves the OPAT program \$998,781.00.

The Parent Education Program is authorized in Section 10-105.3 of Title 70 of the Oklahoma Statutes: *"The State Board of Education shall develop and implement a program of parent education which provides practical information and guidance to parents regarding the development of language, cognition, social skills and motor development of young children birth to age three . . ."*

The 37 school districts or local cooperatives on the attached list are recommended for Board approval to receive funding for the OPAT parent training program school year 2014-2015 to serve an estimated 1,634 families.
