**SUBCHAPTER 4. COMMON CORE STATE STANDARDS [REVOKED]**

- a. **What is the purpose of the proposed rule change?**  
The purpose of the proposed change is to revoke the 2011 rules at 210:15-4-1, 210:15-4-2, and 210:15-4-3 pertaining to adoption and implementation of Common Core academic standards. The proposed rule is necessary to comply with HB 3399, which went into effect on June 5, 2014. The proposed permanent rule, if adopted, will replace the emergency rule currently in effect.
- b. **What classes of persons will be affected by the proposed rule change and what classes of persons will bear the costs of the proposed rule change?**  
The proposed changes will affect public school students and teachers, as well as public school districts and public schools.
- c. **What classes of persons will benefit from the proposed rule change?**  
The proposed changes will benefit public school students and teachers as well as public school districts and public schools.
- d. **What is the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions?**  
The agency does not anticipate any economic impact upon affected classes of persons or political subdivisions as a result of implementation of the proposed rule change at this time. Any economic impact relating to revocation of state Common Core academic standards results is attributable to the implementation of HB 3399, rather than the proposed rule.
- e. **What is the probable cost to the agency to implement and enforce the proposed rule change?**  
The agency does not anticipate any cost to the agency to implement and enforce as a result of the proposed change in the rule at this time. Any costs of implementation and enforcement relating to revocation of state Common Core academic standards is attributable to the implementation of HB 3399, rather than the proposed rule. Additional record keeping, if any, will be performed by existing staff.
- f. **What is the economic impact on any political subdivision to implement the proposed rule change?**  
The agency does not anticipate any economic impact on any political subdivision to implement the proposed rule change at this time.
- g. **Will implementing the rule change have an adverse effect on small business as provided by the Oklahoma Small Business Regulatory Flexibility Act?**  
The agency does not anticipate any adverse economic impact on small business as a result of the proposed rule change at this time.
