The State Board of Education met in special session at 10:05 a.m. on Friday, April 3, 2012, in the Board Room of the Oliver Hodge Education Building at 2500 North Lincoln Boulevard, Oklahoma City, Oklahoma. The final agenda was posted at 9:50 a.m. on Thursday April 2, 2012.

CALL TO ORDER AND ROLL CALL

Superintendent Barresi called the State Board of Education special meeting to order at 10:05 a.m. and welcomed everyone to the meeting. Ms. Holland called the roll and ascertained there was a quorum.

PLEDGE OF ALLEGIANCE, OKLAHOMA FLAG SALUTE, AND MOMENT OF SILENCE

Superintendent Barresi led Board members and all present in the Pledge of Allegiance to the American Flag and a salute to the Oklahoma Flag, and a moment of silence.

STATE SUPERINTENDENT

Superintendent Barresi expressed her sincere gratitude to Board Members in attending the special meeting.

PUBLIC COMMENT

Mr. Robert Brown said he was a graduating senior of Tulsa Central High School class of 2012, and wished to address the EOI testing and approvals. The EOI testings have high standards for students to pass four tests in order to graduate and attend college. He said you guys say there is not enough doctors and lawyers. Well, I want to be a lawyer, go to college, study pre-law for four years, and on to law school. The tests hold students back from completing their goals of becoming doctors, lawyers, firemen, and police officers. The SBE is letting the tests define us instead of the students defining themselves, and allowing the tests to be our personality instead of us being our personality. The tests increase the dropout rate instead of decreasing it because most kids give up when they do not pass or complete other goals because the tests are holding them back. This is the first class that this has been done to and is the last time they are doing this, too. Since this is the last time this is being done, he should be approved to go through. These tests are defining us instead of letting our grades define us. Mr. Brown said on grades alone he can pass at the top of his class; he has a 3.5 grade point average (GPA), and has been accepted to four colleges. He asked again to not allow the tests to define students but to allow students to define their own selves by their grades, personality, attitude, and background. Thank you.

Ms. Tenna Whitsel, Tulsa Public Schools, said to improve student success through service to schools, parents and students, leadership for education reform regulation and deregulation of state and federal laws to provide accountability while removing any barriers to student success. She is sure those of you around the table recognize this is the mission statement of the State Board of Education. The last six words that are most important to her are "removing any barriers to student's success." Last week the SBE reviewed several appeals from Tulsa Public Schools, and out of all the appeals seven were approved. Two were approved because they met extenuating circumstances as outlined in the legislation and the fact the students had college letters from selective universities. The other five were approved because of extenuating circumstances that reached out to the hearts of the Board Members. A student in one appeal had a college letter of acceptance, like Mr. Robert Brown does, a college that is not

considered a selective college. Board Members saw in their good judgment at that time to approve the appeal because they saw success for that student in doing so. When reviewing the appeals again, she noticed 14 of the appeals had similar situations where students had college letters of acceptance and scholarships but were not granted. There were also compelling reasons for others, but it is up to you, the Board Member, to decide their fate. She understands it is a heavy burden and one that is taken very seriously. Undoubtedly the review of each case is time consuming, tedious, and it can be overwhelming. You are asked to review each of the appeals, to make life altering decisions for each of these appeals, and as the last two cases are reviewed, take into consideration each one of these students also have letters of acceptance to a college. Although the colleges are not selective, they are colleges worthy of consideration for these students. Ms. Whitsel respectfully asked Board Members to take the time to review each of the cases as charged, and in the review keep in mind and heart those last six words in the SBE mission statement "removing barriers to student success." She requested approval of the appeals in order to put them with the other approvals. Thank you for your time.

EXECUTIVE SESSION

Convene into Executive Session Approved

Board Member Shdeed made a motion to convene into Executive Session at 10:15 a.m. Board Member Price seconded the motion. The motion carried with the following votes: Mr. Price, yes; Mr. Shdeed, yes; Ms. Hofmeister, yes; and Superintendent Barresi, yes.

Board Member Price said Point of Order for the future, a motion seconded to go into Executive Session was automatically approved without a vote.

Ms. Kimberly Richey, Legal Counsel, advised the law required a roll call vote to proceed into Executive Session.

Return to Open Session Approved

Board Member Shdeed made a motion to reconvene to Open Session at 12:20 p.m. Board Member Price seconded the motion. The motion carried with the following votes: Ms. Hofmeister, yes; Mr. Shdeed, yes; Mr. Price, yes; and Superintendent Barresi, yes.

Recommended Approval Based Upon Verified Evidence Meeting the Criteria contained in OAC 210:10-13-16 for Granting an Exception to ACE Graduation Requirements Approved

Board Member Shdeed made a motion to approve the approval recommendation of Consent Docket-ACE Appeal item 6. (a)-Choctaw 12-0050. Board Member Hofmeister seconded the motion. The motion carried with the following votes: Mr. Price, yes; Mr. Shdeed, yes; Ms. Hofmeister yes; and Superintendent Barresi, yes.

Board Member Hofmeister asked to move Tulsa 12-0075 from the Consent Docket-ACE Appeal item 6. (b)

Recommended Denial Based Upon the Lack of Verified Evidence Meeting the Criteria contained in OAC 210: 10-13-16 for Granting an Exception to ACE Graduation Requirements Approved

Board Member Price made a motion to approve the denial recommendation of Consent Docket-ACE Appeal item 6. (b) Tulsa 12-0095. Board Member Shdeed seconded the motion. The motion failed with the following votes: Ms. Hofmeister, abstain; Mr. Shdeed, yes; Mr. Price, yes; and Superintendent Barresi, yes.

Board Member Hofmeister asked if they were able to take the vote first and discuss Tulsa 12-0075?

Board Member Shdeed made a motion to table the denial recommendation of Tulsa 12-0095 under Consent Docket-ACE appeal item 6. (b). Board Member Price seconded the motion. The motion carried with the following vote: Mr. Price, yes; Mr. Shdeed, yes; Ms. Hofmeister, yes; and Superintendent Barresi, yes.

Board Member Hofmeister made a motion to disapprove the denial recommendation of Consent Docket-Ace Appeal item 6. (b), Tulsa 12-0075. She motioned to approve and grant a waiver to the Tulsa-12-0075 student who passed all but one of the EOIs. Board Member Shdeed seconded the motion.

Board Member Hofmeister said the Tulsa 12-0075 student attempted the one EOI five times and came within 13 points of passing that EOI. The student has also been granted acceptance into a university which compels her to want to see the student be granted a waiver.

Board Member Price said Tulsa 12-0075 was compelling to him because of several things, i.e. the above 700 English II, III, high biology ACT score, tested five times, and took the course twice. The letter was revealing when it said the student took the course a second time, the teacher was never in school often times sick and just not there, did tutoring and sought to do the projects. If this had been several months ago, he would have denied the waiver because there was time to do a project. Up to the point, if the letter is correct, there was a dereliction of duty by the school. To tell the student it was too late to complete a project, the teacher was not showing up, the student tries to take the course twice, and then still scores within 13 points of passage of that one EOI, it is deemed an extenuating circumstance. This was someone who was tutored and tried very hard but the school basically failed them. The student has worked hard enough to make up for the lack of an education in high school and will have a good chance at succeeding. Board Member Price said he was in support of granting a waiver.

The motion carried with the following votes: Ms. Hofmeister, yes; Mr. Shdeed, yes; Mr. Price, yes; and Superintendent Barresi, yes.

Board Member Shdeed made a motion to approve the denial recommendation of Tulsa 12-0095. Board Member Price seconded the motion.

Board Member Hofmeister said the Board wanted to make sure provisions were available to this particular student so that the student would be able to continue forward even at the university in which they have been accepted, and that assurance steps are in place through the actual university, which the Board was able to verify.

Superintendent Barresi said this is not a denial of a diploma, but a denial of an appeal.

Board Member Hofmiester said this student also needed to take and pass a few more EOIs and was a part of the decision making process in having to reach a very difficult decision.

Board Member Price said he could not justify granting a waiver because the student failed three different courses. There was no indication the student attempted a project and left it blank on the application. So it is a sign that a student just expects a waiver and does not want try accomplishing what needs to be done. The fact is in some schools, they can start without a diploma but in the worst case scenario they have to hunker down and complete the project tests and start second semester.

The motion carried with the following votes: Mr. Price, yes; Mr. Shdeed, yes; Ms. Hofmiester, yes; and Superintendent Barresi, yes.

Recommended Dismissal Based Upon Verified Evidence Meeting the Criteria contained in OAC 10-13-16 for Granting an Exception to ACE Graduation Requirements Approved

Board Member Shdeed made a motion to approve the dismissal recommendation of Salina 12-0130 under Consent Agenda-Ace Appeal item 6. (c). Board Member Hofmeister seconded the motion. The motion carried with the following votes: Ms. Hofmeister, yes; Mr. Shdeed, yes; Mr. Price, yes; and Superintendent Barresi, yes.

ADJOURNMENT

There being no further business the meeting adjourned at 12:50 p.m. Board Member Shdeed made a motion to adjourn and Board Member Price seconded the motion. The motion carried unanimously.
