- Follow legislative mandates (HB3399) implementation by Fall 2016
- Define characteristics and outcomes of the new standards
- Create standards that are clear, concise, objective, measurable, and grade-level appropriate
- Recognize that standards do not require a specific teaching methodology or curriculum
- Gather input from teachers, experts, and public

- Prepare students for success in a college general education mathematics course
- Prepare students for success in English language arts
- Create all standards to be assessable
- Create standards that demonstrate vertical alignment from one grade level to the next and horizontal alignment to ensure appropriate grade level placement

#### **Definition of College and Career Ready**

- Content knowledge to provide critical thinking
- Multiple pathways for success

#### What criterion determines a high-quality standard?

- Cognitive Rigor
- Horizontal and vertical connections
- Concise
- Appropriate to grade level
- Consideration of depth of knowledge
- Readiness standards (non-negotiable standards group for foundational content and skills) grade bands
- Authenticity Provide content with real-life purpose
- User friendly so that teachers are able to implement standards effectively in the classroom
