Everything you Need to Know About Economic Disadvantaged (Demographic Overlay) – Spring 2018

What is it used for?

The Economic Disadvantaged column is used to identify the student in the Economic Disadvantaged Student Group for Accountability Reporting.

Where does it come from?

This data comes from your Student Information System (SIS) to The Wave via the Student Personal object.

What is the definition of Economic Disadvantaged?

This element answers the question, "Does the student's situation meet the criteria that would "qualify" this student for Free or Reduced Price lunch regardless of whether or not the student receives the benefits or whether or not the student has access to a meal?" If yes, the student is Economically Disadvantaged.

Note: A student may qualify for a Free lunch, but the parent/guardian may refuse the service. This student would be Economic Disadvantaged = Yes.

A student may not have access to a meal, but their situation would have qualified them for a meal if access to a meal had been made available. This student would be Economic Disadvantaged = Yes.

Current Data Validations

The student will appear in your Data Validation Wizard if any of the following are true in relation to the Economic Disadvantaged column:

- A value other than "Yes" or "No" is sent.
- No value is sent.
- A value of "Yes" is sent for EconomicDisadvantage and the value of "NA" is sent for LunchEligibilityDetermination.
- A value of "No" is sent for EconomicDisadvantage and any value other than "NA" is sent for LunchEligibilityDetermination.
- A value of "No" is sent for EconomicDisadvantage and the student is on the Direct Certification List for receiving benefits.
- The value sent for EconomicDisadvantage is "No", but FreeReduced is sent as "Free" or "Reduced"



Everything you Need to Know About ELL (Demographic Overlay) – Spring 2018

What is it used for?

The ELL column is used to identify the student in the English Learner Student Group for Accountability Reporting. The Recently Arrived English Learners (RAEL) will be reviewed in the Assessment Correction window.

Where does it come from?

This data comes from your Student Information System (SIS) to The Wave via the Student Personal object.

What is the definition of ELL?

ELL stands for English Language Learner. It has been referred to by several other names including: Limited English Proficient (LEP) and English Learner (EL). A student is identified as EL if all of the following conditions are met:

1. A language other than English is spoken more often than English in the home OR a language other than English is spoken less often than English in the home.

AND

2. Upon entering school, the student has been administered the Pre-K Screener, the Kindergarten WIDA ACCESS Placement Test (K-W-APT) or the WIDA ACCESS Placement Test (W-APT) and has a qualifying score below the proficiency level. (Refer to the Office of Assessment for current proficiency levels.)

Note: The student will continue to be designated as EL if they take the ACCESS for ELLs 2.0 Paper in the spring and score below the proficiency level required for exit on Tier B or C.

Current Data Validations

The student will appear in your Data Validation Wizard if any of the following are true in relation to the ELL column:

- A value other than "Yes" or "No" is sent.
- No value is sent.
- A value of "Yes" is sent for ELL and the only Language Code provided is "eng" or "und".
- The value sent for the ELL column is not aligned to the EnglishProficiency_Code.
- A value of "Yes" is sent for ELL and "No" for Bilingual.



Everything you Need to Know About ELL 1st and 2nd Year Proficient (Demographic Overlay) – Spring 2018

What is it used for?

The ELL 1st Yr Prof and ELL 2nd Yr Prof columns are used to identify the student as a former English Learner for Accountability Reporting.

Where does it come from?

This data comes from your Student Information System (SIS) to The Wave via the Student Personal object as the English Proficiency Code and English Proficiency Other Code.

The English Proficiency Code for these students will be "1636" which is described as <u>redesignated</u> as fluent English proficient.

The English Proficiency Other Code will determine the time frame for the redesignation and the bilingual status of the student. The code for 1^{st} year proficient students who are bilingual is "01", and for those who are not bilingual it is "03". The code for 2^{nd} year proficient students who are bilingual is "02", and for those who are not bilingual it is "04".

The other valid codes ("05","06","NA"), identify 3 or more years proficient and bilingual, 3 or more years proficient not bilingual, and Not Applicable respectively.

What is the definition of ELL Proficient?

The student is ELL Proficient when they were previously identified as an English Learner (EL), but have tested proficient on the ACCESS for ELLs 2.0 for EL's test. It is important to note that a student is not identified as ELL Proficient in the year that they test proficient, but in subsequent years.

Current Data Validations

The student will appear in your Data Validation Wizard if any of the following are true in relation to the ELL 1^{st} Yr Prof or ELL 2^{nd} Yr Prof columns:

- The English Proficiency Code is invalid.
- The English Proficiency Code was not provided.
- The English Proficiency Other Code is invalid.
- The English Proficiency Code/Other code does not align with the Bilingual column.
