Attached is an Application to Revoke Certificate and Notice of Hearing that have been filed with the State Board of Education seeking revocation of your Teaching Certificate. A hearing to consider the Application to Revoke Certificate will be held during the State Board of Education meeting at 1:00 PM on December 18, 2014, in Senate Room 535, of the Oklahoma State Capitol, 2300 North Lincoln Boulevard, Oklahoma City, Oklahoma. The State Board of Education's hearing rules are enclosed.

You have the right to appear before the State Board of Education in person, by counsel, or to submit a written statement of your position for the Board's consideration. If you wish to contest the revocation of your teaching certificate and/or have a person attend the hearing and testify as a witness you will need to notify the State Board of Education no later than December 8, 2014, in writing and provide the name and address of all of your desired witnesses. Should you fail to request a hearing to contest the revocation of your teaching certificate the allegations in the application for revocation will be deemed confessed and the State Board of Education will issue a final order to effect the revocation of your teaching certificate as of December 18, 2014.

If you do not wish to contest the recommendation for revocation of your Teaching Certification, please sign and return the enclosed Consent Order using the enclosed envelope.

APPLICATION TO REVOKE CERTIFICATE

COMES NOW, the Oklahoma State Department of Education, and hereby asserts the following statement of facts and matters asserted against Respondent, Jared M. Feroli. The Oklahoma State Department of Education seeks revocation of the Respondent, Jared M. Feroli's Teaching Certificate as set forth in the facts alleged to give rise in this action. The statement of facts and matters asserted is as follows:

1. The Respondent holds a valid Oklahoma Teaching Certificate, in the State of Oklahoma.
2. The Respondent's Teacher certificate with certification number 229394 expires on June 30, 2017.
3. Respondent is certified to teach US History/OK History/Government/Economics (Grades 5 to 12), World History/Geography (Grades 5 to 12).
4. On December 13, 2013, Respondent taught at Newcastle High School.
5. On December 13, 2013, a Newcastle High school custodian witnessed the Respondent and a female student in his classroom with the lights turned off and the door locked.
6. That the female student stated that she was alone in the classroom with Respondent and that the lights were off and the doors were locked and they "started making out". The female stated the Respondent kissed her and grabbed her "butt and boobs".
7. On September 19, 2014, the McClain County District Attorney on behalf of the State of Oklahoma filed charges on the Respondent, Jared M. Feroli, for one count of Sexual Battery, 21 O.S. § 1123(B), which constitutes a felony.

8. That Title 70 O.S. § 3-104(6) provides:

"The supervision of the public school system of Oklahoma shall be vested in the State Board of Education and, subject to limitations otherwise provided by law, the State Board of Education shall:... [h]ave authority in matters pertaining to the licensure and certification of persons for instructional, supervisory and administrative positions and services in the public schools of the state...and shall formulate rules governing the issuance and revocation of certificates..."

9. The State Board of Education's rules in 210:20-9-98(l) provide:

"Teaching certificates/licenses issued by authority of the Oklahoma State Board of Education may be revoked by the board for willful violation of any rule or regulation of the board or any federal or state law or other proper cause."

10. The State Board of Education's rules in 210:20-29-3(b)(7)

"In fulfillment of the obligation to the student, the teacher shall not use professional relationships with students for private advantage."

11. The State Board of Education's rules in 210:1-5-6 provides:


"A Certificate shall be revoked only for a willful violation of any rule or regulation of the State Board of Education, or the United States Department of Education; or a willful violation of any federal or state law; or a conviction for any of the offenses or bases for revocation set forth in 70 O.S. §§ 3-104 or 3-104.1; or for other proper cause."

12. That based upon the information and evidence presented, cause exists to revoke the Teaching Certificate and teacher number 229394 of Jared M. Feroli.

13. That based upon the information and evidence presented, Respondent's Teaching Certificate should be revoked effective December 18, 2014.

Wherefore, the Oklahoma State Department of Education requests that a hearing be held to determine the truth of the allegations set out above and upon proof of the veracity of said Application to Revoke Certificate, that the State Board of Education revoke the Teaching Certificate of Respondent, Jared M. Feroli to be effective December 18, 2014.
